Terry T. reported that there were 28 shooters at the November 3rd animal target shoot. He noted John Hill's immeasurable contributions this year. Terry informed the membership that there have been 1,882 entries for rifle shoots since 2011. The Hangover Shoot on January 1 will begin at 9 AM.

Indoor/Outdoor Pistol

Paul T. spoke about the Wednesday night pistol league. Manny reported on the Thursday night air pistol league. In January, a new shooter clinic will be held on the 2nd and 4th Thursdays.
